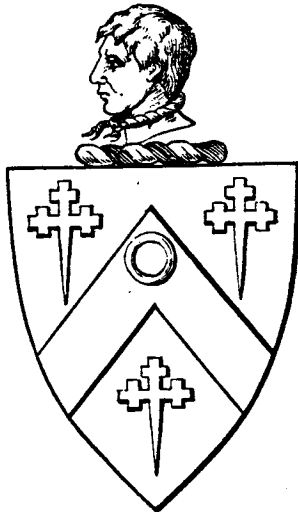


The following pedigree traces the descent of the Davenports of Henbury more fully than could be done in the text.

Davenport of Henbury.

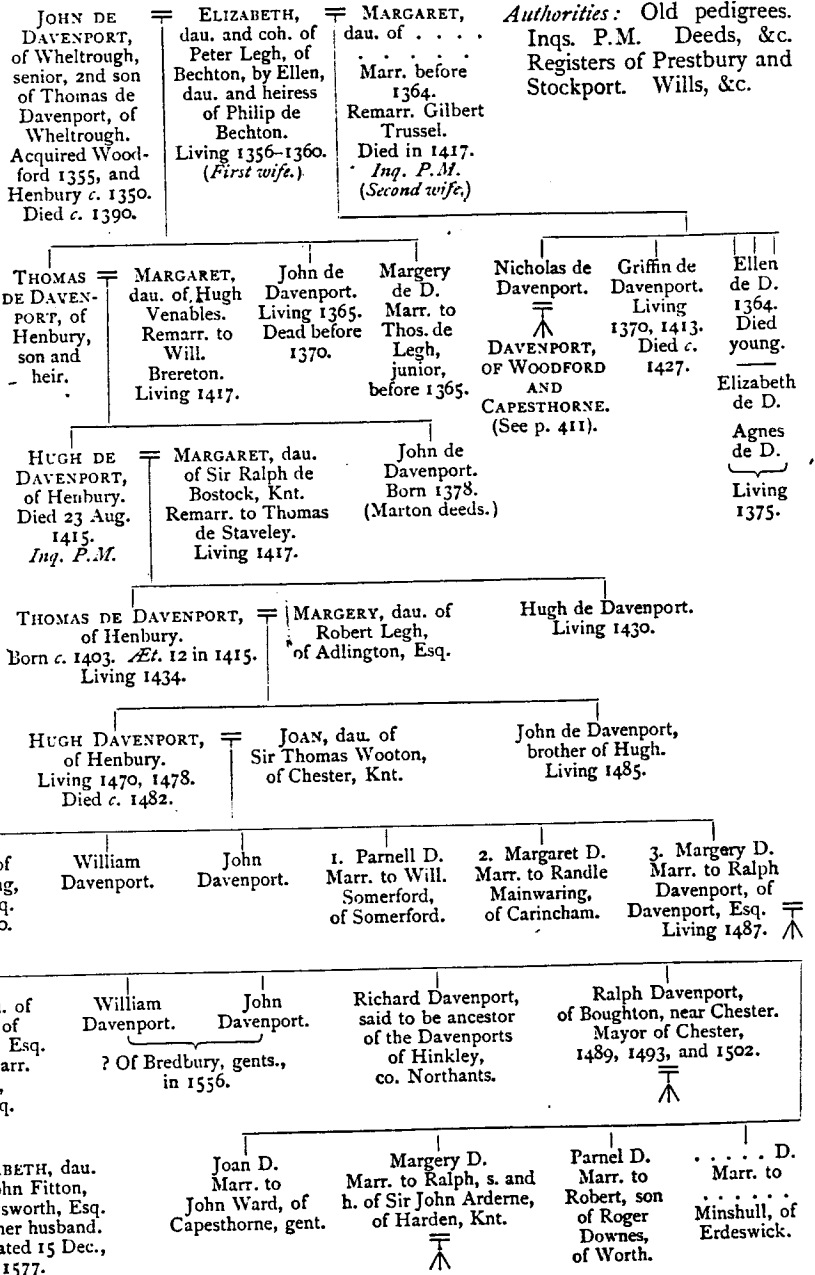


Arms: Argent a chevron between three cross-crosslets fitchée Sable, an annulet of the field for difference.

Crest: A felon's head couped proper, round the neck a halter Or.

JOHN DAVENPORT, of Henbury, Esq. Died April, 1557. Will dated 15 Dec., 1556. To be buried at Prestbury. *Inq. P.M.*

KATHERINE, dau. and coheirss of Sir Randle Mainwaring, of Peover, Knt. Living 1556.

Hugh Davenport. Married to Dorothy, dau. of Laurence Warren, of Poynton, Esq., and widow of Newton.

Peter Davenport, of Chadkirk, in 1554. Ment. in his mother's will 1577. Roger Davenport, of Chadkirk, 1554.

Alice Davenport. Marr. Sir George Beeston, of Beeston, co. Chester.

Katherine Davenport. Marr. to William Liversage, of Whelock, co Chester. Living 1577.

Amy Davenport. Marr. to William Beard, of Derbyshire. Living 1577.

RANDLE DAVENPORT, of Henbury, Esq. Born c. 1545. *Æt.* 12 in 1557. High Sheriff of Cheshire 1587. Died 19 May; bur. at Prestbury, 23 May, 1613. *Inq. P.M.*

MARY, dau. of George Booth, of Dunham and Bolyne, Esq. Marr. Sett. dated 2 July, 1555. Living 1577.

WILLIAM DAVENPORT, of Henbury, Esq. Born c. 1572. *Æt.* 40 and more in 1613. Lived at Goyt Hall. Bur. at Stockport, 31 Jan., 1634-5. *Inq. P.M.* 1638.

ELIZABETH, dau. and coheirss of Roger Wigston, Esq. Living 1620. Bur. at S., 9 June, 1627. (First wife.)

FORTUNE, dau. of Bur. at Stockport as wife of Wm. D., of Goyt, Esq., 1 June, 1633. (Second wife.)

Thomas Davenport. Bapt. at P., 3 June, 1573. Living 1577.

John Davenport. Bapt. at P., 1 May, 1577.

Dorothy Davenport. Living 1577. Bur. at S., 11 April, 1584.

Joan Davenport. Marr. to Hugh Salusbury.

John Davenport, son and heir-apparent. Bapt. at Stockport, 8 April, 1593. Died before his father, 25 Aug., 1620. *Inq. P.M.*

Margaret, dau. of Sir William Knyveton, of Mercaston, co. Derby, Knt. Marr. Sett. dated 20 April, 1612. Surv. her husband. Living 1638.

William Davenport. Bapt. at S., 13 May, 1599. Living 1613, 1640.

Randle Davenport. ? Bapt. at P., 2 July, 1600. Living 1613.

Edward Davenport. Bapt. at S., 27 July, 1595. Bur. there, 31 Aug., 1599.

Mary D. Bapt. at S., 5 April, 1590. Elizabeth D. Bapt. at P., 31 March. Bur. at S., 11 June, 1591.

Susanna Davenport. Bapt. at S., 28 April, 1594. Bur. there, 15 Nov., 1637.

WILLIAM DAVENPORT, of Henbury, Esq. Born c. 1613. *Æt.* 7 in 1620. Died 24 June, 1640. Will dated 19 June, 1640.

MARY, dau. of Sir Thomas Milward, Knt. Chief Justice of Chester. Marr. Sett. 1 July, 1635. Died 6 Jan., 1639.

Isabel Davenport, only daughter and heiress. Marr. before 1657. Bur. at Prestbury, 5 June, 1689.

SIR FULK LUCY, Knt. M.P. for co. Chester in 1664. Son of Sir Thomas Lucy, of Charlecote, co. Warwick, Knt. Of Henbury *jure uxoris*. Died c. 1677.

DAVENPORT LUCY, of Henbury, Esq. (son and heir). Died before 1691. Will dated 15 Oct., 1688. S.P.

GEORGE LUCY, of Henbury, Esq. Succ. his brother. Sold Henbury, 7 Dec., 1693. Living 1720.

William Lucy. Living 1688. Fulk Lucy. Living 1688.

Fulk Lucy. Bapt. and bur. at P., 1661. Robert Lucy. Bapt. 1664. ? Bur. 1669.

Spencer Lucy. Bur. at P., Aug. 1, 1680. Elizabeth Lucy. Bapt. and bur. 1662.

Mary Lucy. Marr. to Purcell. Living 1688.

Alice Lucy. Bapt. at P., 16 June, 1660. Marr. at P., 16 April, 1689, to the Rev. John Hammond, Rector of Gawsorth.

Catherine Lucy. Bapt. at P., 26 April, 1666. Bur. there, 17 March, 1692-3. Unmarr.

Bridget Lucy. Bur. at P., 29 Jan., 1670.

Isabel Lucy. Bridget Lucy. Both living unmarr. 1688.
